County Auditor Dusty Rhodes has issued an updated comparison of school tax levies in each of Hamilton County's twenty-three (23) school districts.

"This allows residents to determine where their school district now ranks among the County's districts in terms of actual tax cost," said Rhodes. Formerly all that could be easily compared were millage rates, which require various conversions to arrive at readily understandable numbers.

Following are the schools' annual portion of the total property tax bill paid by an owner-occupied residence for each \$100,000 of market value.
